NOTICE OF TRANSFER FEE

(Thompson River Ranch)

THIS NOTICE OF TRANSFER FEE (the “**Notice of Transfer Fee**”) is dated as of September 1, 2011, and is given by HC DEVELOPMENT & MANAGEMENT SERVICES, INC. (the “**Declarant**”) in accordance with C.R.S. § 38-35-127 (the “**Transfer Fee Act**”). Unless otherwise defined herein, all initially capitalized phrases, terms, and words in this Notice of Transfer Fee have the same meaning that such initially capitalized phrases, terms, and words have in the Master Declaration (as defined in Recital B below).

RECITALS:

A. The Declarant is the declarant pursuant to the Master Declaration. The Declarant is in the process of developing the Community Area as a planned community containing attached and detached single-family residences (the “**Community**”).

B. In furtherance of its development of the Property, the Declarant recorded a Master Declaration of Covenants, Conditions, and Restrictions (as amended and supplemented, the “**Master Declaration**”) on October 2, 2006, at Reception No. 20060074437 of the real property records of the Clerk and Recorder of Larimer County, Colorado. Among other things, the Master Declaration contains a covenant (the “**Transfer Fee Covenant**”) imposing a Transfer Fee on the Transfer of any portion of the Property.

C. Among other things, the Transfer Fee Act requires that the payee of a transfer fee, as a condition of payment of a transfer fee, must record against the residential real property burdened by a transfer fee covenant, in the office of the county clerk and recorder for the county in which the residential real property is situated, a notice of transfer fee. This Notice of Transfer Fee is the notice of transfer fee provided for in the Transfer Fee Act.

NOTICE OF TRANSFER FEE:

PURSUANT TO AND IN FURTHERANCE OF THE TRANSFER FEE ACT, Declarant hereby gives the following notice regarding the Transfer Fee:

1. Amount of Transfer Fee. The amount of the Transfer Fee is one half of one percent of the sales price paid by a buyer to a seller for a residence located in the Community. The Transfer Fee is divided into the following two portions:

a. Community Portion of the Transfer Fee. Pursuant to **Section 7.2.b** of the Master Declaration, the Collection Agent will pay 25% of all Transfer Fees collected to the Foundation. This portion of the Transfer Fee is referred to herein and in the Master Declaration as the "**Community Portion of the Transfer Fee.**"

b. Development Portion of the Transfer Fee. Pursuant to **Section 7.2.b** of the Master Declaration, the Collection Agent will pay 75% of all Transfer Fees collected to the Development Company. This portion of the Transfer Fee is referred to herein and in the Master Declaration as the "**Development Portion of the Transfer Fee.**"

2. Actual Cost Examples. The following are examples of the calculation of the Transfer Fee for the sale of a residence in the Community:

a. Example One: Sales Price of \$250,000. The Transfer Fee that would be due with respect to a residence having a sales price of \$250,000 would be calculated as follows:

i. Sale Before October 2, 2056. If a residence is sold in the Community for sales price of \$250,000 before October 2, 2056, then the Transfer Fee due at the time of such sale would be \$1,250 ($\$250,000 \times 0.005 = \$1,250$). In this example, the Collection Agent would pay from the Transfer Fee (A) \$312.50 to the Foundation as the Community Portion of the Transfer Fee ($0.25 \times \$1,250 = \312.50) and (B) \$937.50 to the Development Company as the Development Portion of the Development Fee ($0.75 \times \$1,250 = \937.50).

ii. Sale After October 2, 2056. If a residence is sold in the Community for a sales price of \$250,000 after October 2, 2056, then the Transfer Fee due at the time of the sale would be \$312.50 (*i.e.*, the Community Portion of the Development Fee of \$312.50, as calculated in clause (A) of subparagraph 2.a.i above).

b. Example Two: Sales Price of \$500,000. The Transfer Fee that would be due with respect to the a residence having a sales price of \$500,000 would be calculated as follows:

i. Sale Before October 2, 2056. If a residence is sold in the Community for a sales price of \$500,000 before October 2, 2056, then the Transfer Fee due at the time of such sale would be \$2,500 ($\$500,000 \times 0.005 = \$2,500$). In this example, the Collection Agent would pay from the Transfer Fee (A) \$625 to the Foundation as the Community Portion of the Transfer Fee ($0.25 \times \$2,500 = \625) and (B)

\$1,875 to the Development Company as the Development Portion of the Development Fee ($0.75 \times \$2,500 = \$1,875$).

ii. Sale After October 2, 2056. If a residence is sold in the Community for a sales price of \$500,000 after October 2, 2056, then the Transfer Fee due at the time of the sale would be \$625 (*i.e.*, the Community Portion of the Development Fee of \$625, as calculated in clause (A) of subparagraph 2.b.i above).

c. Example Three: Sales Price of \$750,000. The Transfer Fee that would be due with respect to the a residence having a sales price of \$750,000 would be calculated as follows:

i. Sale Before October 2, 2056. If a residence is sold in the Community for a sales price of \$750,000 before October 2, 2056, then the Transfer Fee due at the time of such sale would be \$3,750 ($\$750,000 \times 0.005 = \$3,750$). In this example, the Collection Agent would pay from the Transfer Fee (A) \$937.50 to the Foundation as the Community Portion of the Transfer Fee ($0.25 \times \$3,750 = \937.50) and (B) \$2,812.50 to the Development Company as the Development Portion of the Development Fee ($0.75 \times \$3,750 = \$2,812.50$).

ii. Sale After October 2, 2056. If a residence is sold in the Community for a sales price of \$750,000 after October 2, 2056, then the Transfer Fee due at the time of the sale would be \$937.50 (*i.e.*, the Community Portion of the Development Fee of \$937.50, as calculated in clause (A) of subparagraph 2.c.i above).

3. Date or Circumstances Under Which the Transfer Fee Expires. The Declaration provides that the Transfer Fee will be due during the Transfer Period. The Declaration further provides that the Transfer Period (a) began on the date that the Declarant Recorded the Declaration (*i.e.*, October 2, 2006), (b) will end on October 2, 2056, with respect to the Development Portion of the Transfer Fee, and (c) has no expiration with respect to the Community Portion of the Transfer Fee.

4. General Purpose and Use of Transfer Fees. All Transfer Fees shall be applied, held, and used for the following uses and purposes:

a. Community Portion of Transfer Fee. The Foundation will use the Community Portion of the Transfer Fee for the public purpose of promoting art, cultural events, education, and youth programs directly and indirectly benefiting Residents living within the Community Area. The Board of Directors of the Foundation shall be responsible for the manner and time of the disposition of the Community Portion of the Transfer Fee in accordance with articles of incorporation and bylaws of the Foundation.

b. Development Company Portion of Transfer Fee. The Declarant shall apply the Development Company Portion of the Transfer Fee received by it (i) as a credit towards developer advances extended by the Declarant to the District for the construction of public and other improvements permitted and provided for in the service plan of the District and (ii) then towards (A) the reimbursement of the costs and expenses incurred by the Declarant in connection with the development, construction, marketing, and sale of the Community and in

connection with the credit enhancement, guarantees, and other obligations incurred in connection with the financing necessary for the development of the Community and (B) the compensation of the Declarant for the financial obligations and risks it undertook in such development activities and guarantees of financial obligations. in connection with developing a master plan for the Project Area and providing the credit enhancement necessary for the Operating District and the Operating District to obtain the financing necessary for it to develop the Common Areas (including, but not limited to, the funding of the capital costs for the construction of Common Area Facilities).

5. Payee Contact Information. Thompson River Ranch Metropolitan District No. is the agent (the "**Collection Agent**") responsible for the collection of Transfer Fees and the payee ("**Payee**") to whom Owners shall make payments of Transfer Fees. The contact information for the Collection Agent and the Payee (including the mailing address of the Collection Agent and Payee) is as follows:

6. Owner and Description of Property Burdened by Transfer Fee Covenant. The names of the owners of the residential real property burdened by the Transfer Fee Covenant and the residential real property are listed in Schedule 1 and Schedule 2 attached hereto.

7. Method for Releasing any Lien Recorded Pursuant to the Transfer Fee Covenant. If a Transfer of a Unit (a "**Transferred Unit**") occurs and a Transfer Fee is due but not paid with respect to such Transfer, then the following shall apply:

a. Lien. The unpaid Transfer Fee shall be (i) an obligation due and owing from the transferor and the transferee and the Collection Agent may pursue such remedies and rights as are available to it at law, in equity, or otherwise to collect such sum and (ii) the unpaid Transfer Fee shall be a lien (the "**Lien**") upon the Transferred Unit having the priority and bearing interest at the manner and rate specified in the Master Declaration. At its option, the Collection Agent may record the Lien in the real estate records of the county in which the Transferred Unit is located.

b. Satisfaction and Release of Lien. Within five business days following payment of the Transfer Fee in full, then (a) the Collection Agent shall execute and deliver to the Owner a full release of the Lien, which release shall be in form suitable for recording and (b) if Collection Agent recorded the Lien, then, at its cost and expense, the Owner of the Transferred Unit (*i.e.*, the transferee of the Transferred Unit) shall record the release of the Lien in the real estate records of the county in which the transferred Unit is located.

8. General Provisions.

a. Master Declaration. Further information concerning the Transfer Fee is set forth in the Master Declaration, which the Declarant incorporates herein and makes a part hereof by this reference.

b. Construction and Interpretation of Notice of Transfer Fee. The Declarant and Payee have executed this Notice of Transfer Fee in furtherance of and pursuant to the Transfer Fee Act. If any term or provision of this Notice of Transfer Fee is found by any court to be inconsistent with or in violation of the Transfer Fee Act or otherwise unenforceable, then (a) such court shall reform this Notice of Transfer Fee so that it will be consistent with and not in violation of the Transfer Fee Act.

c. Modification of Notice of Transfer Fee. Pursuant to the Transfer Fee Act, the Collection Agent reserves and shall have the right to file an amendment to this Notice of Transfer Fee containing (i) new contact information regarding the Payee, (ii) the names of the Owners of Units affected by the Transfer Fee Covenant at the time of such amendment, and (iii) a description of the real property burdened by the Transfer Fee.

d. Prior Transfer Fee Notices. This Notice of Transfer Fee (i) supersedes and (ii) replaces all transfer fee notices, notices of obligation, and other notices regarding transfer fees, and is the Notice of Transfer Fee contemplated by and set forth in the Transfer Fee Act.
